DR. NESTER COHENCA

Dr. Cohenca completed the endodontic program at the Hebrew University in Jerusalem cum laude and received the Best Graduate Student Award. He then served 11 years on faculty at the school while maintaining a private practice limited to endodontics. Thereafter, Dr. Cohenca joined the University of Washington where he completed his endodontic certificate in 2008 and served as Tenured Professor of Endodontics and Pediatric Dentistry from 2005-2014. Currently he serves as Professor at the University of Washington, Professor and Director of Endodontics and the Multidisciplinary Traumatology Unit at Seattle Children's Hospital and maintains a private practice limited to Endodontics in Kirkland, WA. He is a Diplomate of the Israel Board of Endodontics and the American Board of Endodontics. Dr. Cohenca is a Fellow and Past-President of the International Association of Dental Traumatology and received an honorary membership to Omicron Kappa Upsilon National Dental Honor Society. He has published more than 90 peer-reviewed articles, 10 chapters and a book entitled "Disinfection of Root Canal Systems: The Treatment of Apical Periodontitis". Dr. Cohenca provided more than 250 lectures around the world and is well known as one of the experts in dental traumatology, Endo-Pedo related topics, vital pulp therapy, CBCT and root canal disinfection.

DR. ALAN LAW

Dr. Alan Law received his Doctor of Dental Surgery and Certificate in Endodontics from the University of Iowa College of Dentistry, Iowa City, Iowa. He also completed his PhD, "Mechanisms and Modulation of Orofacial Pain", with the Department of Pharmacology at the University of Iowa. Dr. Law has published several of articles in scientific and clinical journals, and has co-authored chapters on The Non-Odontogenic Toothache and Regenerative Endodontics in Pathways of the Pulp, and has lectured at over 300 local, national and international meetings. Dr. Law is a member the American Dental Association, American Association of Endodontics, and Omicron Kappa Upsilon Dental Honor Society, and a Fellow of the American College of Dentists and the International College of Dentists. He is President of the American Association of Endodontists, Past President of the Minnesota Association of Endodontists, and Past President of the American Board of Endodontics. He is in full -time practice in the Twin Cities, and President of The Dental Specialists, a multi-specialty dental practice with over 25 specialists. He is also a Research Associate Professor in the Division of Endodontics at the University of Minnesota.

A. LEE MADDOX, DDS, ESQ.

Dr. Maddox received his D.D.S. degree from the University of Southern California in 1987, his certificate in Endodontics from the University of Southern California in 1989, and his board certification in Endodontics in 1995. Dr. Maddox received his J.D. degree from Whittier College of Law, Costa Mesa, California where he graduated in the top one-third of his class. Dr. Maddox practiced Endodontics and maintained two offices in Orange County for nine years. During this time, his endodontic practice experienced a 700% increase in production during this nine year period. Dr. Maddox has served as a clinical instructor at the University of Southern California School of Dentistry and Loma Linda School of Dentistry. Dr. Maddox has been providing legal services to Dentists for over ten years, helping thousands of doctors with their transition needs as well as general legal services. He has been in the dental transition business as a Practice Broker since 2010. After three successful years as a dental practice broker, Maddox Practice Group was acquired by Henry Schein PPT, the dental practice transition division of Henry Schein Dental, in February, 2013. Management of dental trauma remains a significant clinical challenge affecting health-care providers and patients alike. Falls, accidents and sport-related injuries are the most frequent causes of dental trauma with an estimated prevalence of 30%. Patients can present with a wide variety of injuries ranging from crown or root fractures, to injuries to the supporting periodontal structure, including luxations and avulsions. Treatment is often complex, time consuming, expensive and requires multidisciplinary approaches such as endodontic and periodontal treatments, surgery, orthodontic movements as well as esthetic coronal restoration. Root resorption and ankylosis are the most common sequelae causing a major clinical challenge due to the high risk of infraposition and undevelopment of the alveolar bone. This presentation will discuss the newly published 2020 IADT guidelines for prevention, diagnosis and treatment of traumatized teeth,

regeneration which will be thoroughly discussed and illustrated using advanced 3D technology for diagnosis and





When a patient calls reporting severe pain after root canal treatment it can be disruptive to a practitioner's schedule and psyche.
